**“TERMS AND CONDITIONS”
2018 HRBC YEARLING / MIXED SALE**

The following policies and options for consignors are in effect and will apply to the 2018 HRBC Yearling/Mixed Sale to be conducted on **Wednesday, October 10, 2018** in the Agriplex building across from Fraser Downs’s backstretch. It is the consignor/agents responsibility to be aware of these policies, practices and procedures.

In entering a horse in the HRBC Yearling/Mixed Sale, the Consignor agrees to the following:

1. The horse must be registered with Standardbred Canada or the United States Trotting Association.
2. Horses that are electronically registered **MUST** provide the HRBC office with a signed transfer showing signatures of all owners of horse. If horse is Paper Registered, all owners must sign the back of registration paper or provide a signed transfer to the HRBC Office.
3. Horses must have a **Negative Coggins Test Certificate** with copy on file with HRBC prior to the sale.
4. The horse must be halter broken; HRBC will provide a leather halter for each yearling entered and pay the cost of transferring the horse to the buyer of the horse at time of auction.
5. All consignors must be members in good standing of Harness Racing BC for the year 2018.
6. All purchases are final on an as seen, inspected, and accepted basis.
7. HRBC will not be responsible to any buyer, consignor, or horse owner for any changes to purses, conditions, locations, or information pertaining either to the horse / event; or for cancellation thereof, which may occur after a horse is entered in this Sale; or for any changes to bonus programs funded by HRBC.
8. The consignor agrees to have the mare examined by a veterinarian assigned by HRBC the day of the sale and further agrees to pay costs of such examination and for a certificate thereof. If a mare or filly sold as “in foal” is in fact, “not in foal” or an animal described as a colt but in fact is a gelding, the animal may be returned to the consignor for a refund of the purchase price and the Consignor shall pay any reasonable expenses incurred by the purchaser.
9. The Consignor shall give notice to HRBC when consigning an animal which is a product of an embryo transplant and HRBC reserves the right to state the fact in the catalogue.
10. Minimum Bid is \$ 1,000 + GST = \$1,050.00 + 5% commission will be charged on this amount, even if there is no bid. Opening bids lower than \$1,000.00 will not be accepted.
11. All yearlings that pass through the ring will be nominated to race as a 3 year old in the Sales Stake. Consignors will have the option of paying a Sales Stakes exception fee (see accompanying form) in lieu of entering a yearling into the sale. This **Sales Stake Exception option is limited to BC BREDS only**. Payment of this fee payable to HRBC will make the BC Bred yearling eligible for the 3 year old sales stake under the same terms and conditions as if the Yearling had passed through the sales ring. Please refer to Sales Stake Exception Application form for details of prices and applicable sale taxes.
12. Reserve Bid – Please refer to the Reserve Bid Policy and Procedure form for details.
13. Authorized Agents must complete the “Authorization of Agent” form and submit completed form with the “Application for Sale Entry.”
14. A Withdrawal Policy will be in effect for the 2018 sale. Horses withdrawn from the sale may only be withdrawn with a certificate issued by a **HRBC approved veterinarian**. A separate withdrawal fee of **\$500.00** will apply if this HRBC veterinarian certificate is **not** obtained.
15. Harness Racing BC reserves the right to cancel the Sale should it determine that insufficient entries have been received.
Horses can enter the Agriplex on Tuesday, October 9, 2018 after 2:00 pm and viewing for all horses will on Wednesday, October 10, 2018 at noon providing set up has been completed.
16. All horses must be removed from the Agriplex on Wednesday, October 10, 2018 no later than 11:00 pm.
